

Corona Virus FAQ- Update July 1

Fort Collins Utilities-

Continue to not disconnect services. Anticipate disconnections returning within the next few months; will give notice to customers before any disconnections are made.

Payment plans are being discouraged since customers can only receive 1 per 6months and no disconnections have been carried out. Make payments on accounts as possible, even if partial.

Xcel Energy- • Keeping you connected. We will not disconnect service to any residential customers until further notice.

Evictions- The eviction memorandum has expired, and no new law or executive order has been put in place. Landlords could begin posting eviction notices come June 13th. They are required to give tenants at least 30 days to catch up on past due rent. Late fees can be charged again but not for the period of May 1 – June 13th.

First round of balloon payments could be due July 1, possibility of 3-4 months rent or mortgage due all at once. Freddie Mac and Fannie Mae backed mortgages are still protected from foreclosures

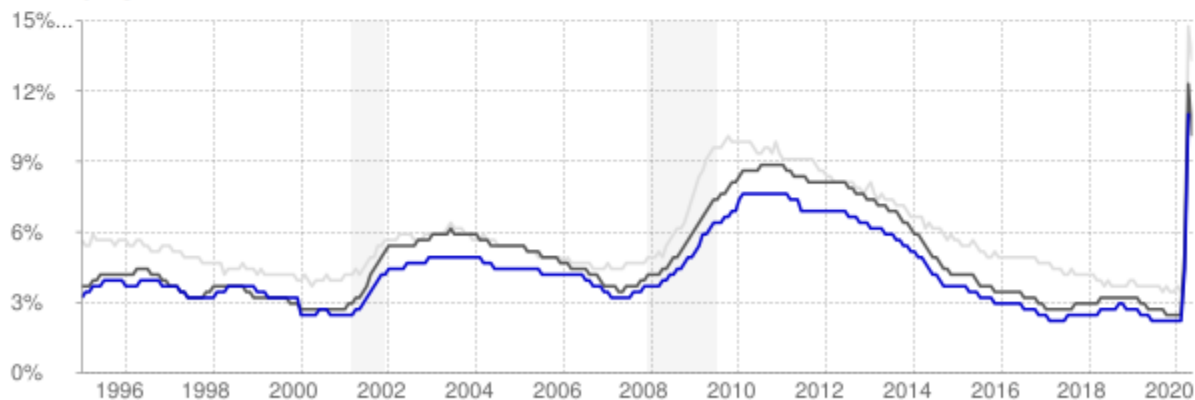
Fort Collins, Colorado Unemployment

The BLS reported that the unemployment rate for Fort Collins rose 6.6 percentage points in April 2020 to 11.0%. For the same month, the metro unemployment rate was 1.2 percentage points lower than the Colorado rate. The unemployment rate for Fort Collins in April 2020 is at a new high. Unemployment Rate	April 2020	Month/Month	Year/Year
National	14.7%	+10.3	+11.1
Colorado	12.2%	+7.0	+9.3
Fort Collins	11.0%	+6.6	+8.5

Note: Metro level data is now seasonally adjusted.¹ All comparisons are made with April 2020 data as May metro level unemployment data has not yet been released.
